The Board of Selectmen will hold an Emergency Meeting to discuss and implement an Executive Order related to the Families First Coronavirus Response Act, specifically the "Emergency Family and Medical Leave Expansion Act" and the "Emergency Paid Sick Leave Act", which go into effect on April 1, 2020.

The Board of selectmen will open the meeting and enter into executive session for the following purposes: Per M.G.L. c. 30A, § 21(a) (2) To conduct strategy sessions in preparation for negotiations with nonunion First Responder personnel; and per M.G.L. c. 30A, § 21(a) (3) to discuss strategy with respect to collective bargaining: NEPBA Local 120, UPSEU Local 424M, IAFF Local 1847; whereas an open meeting may have a detrimental effect on the bargaining positions of the Board of Selectmen, and the Chair so declares.
