Cup to Pint wants the COD to help fund raise in order for the funds to benefit the COD. COD members stated they were willing to solicit businesses to help. Cup to Pint is looking for people to greet the finishers. The race is not fully accessible, which may be a concern to some benefactors. Lance Travellllion is going to look into the price of T-shirts so members would be identifiable at the race. There will be weekly race meetings at the Pint. COD members will try and send at least one member each week.
