## SUPPLEMENTARY INFORMATION APPLICATION FOR AN ENTERTAINMENT LICENSE

**FEE: \$100/annual  
\$ 25/event**

NOTE: Pursuant to Massachusetts General Laws, Chapter 140, Sections 181 and/or 183A, the Board of Selectmen is empowered to license a wide variety of entertainment. The Board requires the following information to be supplied. Within 45 days following the receipt of this application, the Board may either grant the license or provide an opportunity for a public hearing (advance notice of seven days will be given). A hearing fee (to cover costs of publication and abutter notification) may be required for new applications or amendments to existing licenses.

The application must be returned with payment. While only one license is required for each establishment, each form of entertainment must be fully disclosed. Additional forms of entertainment may be included after submission by amending the application.

Massachusetts General Laws provided that the Board of Selectmen may deny licenses to individuals or corporations in default of municipal taxes or fees (Chapter 4, Section K).

This application is not used for licensing of coin-operated games, juke boxes, or pool tables. In addition, any entertainment which is conducted on a Sunday (including entertainment which carries over past 12 midnight on Saturday) must have written approval by the Massachusetts Commission of Public Safety.

**FIRE SAFETY COMPLIANCE** -- Certain establishments will require a Fire Safety Certification from the Building Inspectors/Fire Inspector before offering entertainment. All entertainment applications will be reviewed and any compliance matters must be resolved prior to issuance of local permit, as well as Massachusetts Sunday permit.
