There were approximately 2 outfalls with dry weather flow which will need further investigation. Samples will be collected.

The Town requires a stormwater permit for all construction activity whether a minor project (under 1 acre) or a major project 1+ acres. Each site is inspected on a monthly basis or rainfall greater than .25". There were three sites where erosion control measures failed. Owners were notified and repairs were performed immediately.


