

SPECIAL TOWN MEETING
JUNE 12, 1991

ATTENDANCE:

In accordance with the Warrant, as posted, the inhabitants of the Town of Wilbraham, qualified to vote in Town affairs, met in Minnechaug Regional High School. At 8:05 p.m., Moderator Arthur F. Dionne noted that a quorum was present and the call of the meeting was read by Town Clerk Mary A. Irla.

Newly elected Town Moderator Arthur F. Dionne introduced himself to the voting body and stated that he would like to reinstitute the ceremonial Salute to the Flag prior to the start of each Town Meeting. Moderator Dionne then led the voting body in the Pledge of Allegiance.

ARTICLE 1: Voted Unanimously that the Town vote to authorize the Board of Selectmen to explore funding mechanisms to provide ambulance service to Wilbraham. (Note: The moderator noted that this was not a proper motion and would accept a vote on the motion only for a sense of the Town Meeting.)

ARTICLE 2: Voted by a Majority that the Town amend the Town By-Laws by deleting Section 302, Town Collector, and Section 303, Town Treasurer, and adding a new Section 426, Treasurer-Collector to read: The Board of Selectmen shall appoint a Treasurer-Collector for an indefinite period.

ARTICLE 3: Finance Committee Recommends. Voted Unanimously that the Town transfer the sums of:

\$6,000 from previously appropriated but unexpended funds in the FY 1991 Budget 066, Perry Barn Expenses, to FY 1991 Budget 702, Interest Expenses;

\$10,000 from previously appropriated but unexpended funds in FY 1991 Budget 301, Highway Salaries, to FY 1991 650, Gasoline;

\$31,250 from previously appropriated but unexpended funds in the FY 1991 Budgets 019, Town Report Expenses (\$2,300), 025, Accounting Expenses (\$4,425), 049, Town Office Salaries (\$65), 077, Group Insurance (\$4,832), 101, Police Salaries (\$4,961), 103, Fire Expenses (\$700), 111, Dispatch Salaries (\$1,370) 111, Dispatch Expenses (\$1,375), 113, Building Inspector Salaries (\$2,838), 331, Engineering Salaries (\$1,084), and 551, Veterans Expenses (\$7,300), to FY 1991 Budget 103, Fire Salaries; and

\$20,768 from previously appropriated but unexpended funds in FY 1991 Budget 077, Group Insurance, to FY 1991 Budgets 003, Selectmen Salaries (\$4,500), 003, Selectmen Expenses (\$800), 025, Accounting Salaries (\$2,160), 029, Assessors Salaries (\$1,229), 033, Collectors Salaries (\$275), 039, Town Clerk Salaries (\$2,012), 045, Town Counsel Expenses (\$4,000), 051, Computer Coordinator Salaries (\$192), 051, Computer Coordinator Expenses (\$1,400), 063, Planning Salaries (\$1,499), 112, Dispatch Equipment (\$800), 113, Building Inspector Expenses (\$500), 129, Sealer of Weights & Measures Expenses (\$50), 131, Civil Defense

Salaries (\$14), and 621, Recreation Salaries (\$1,337).
